### Fellowship Overview

**Role Overview:** The PIFP Summer Fellow will support the CFC Philanthropy Team with integrating youth insight learnings and regional knowledge into the decision-making process for the Youth Health and Well-Being funding opportunity, a \$6-8 million funding cycle that supports adolescents ages 9-25 and their families across Colorado.

The PIFP Summer Fellow will also have the opportunity to customize their fellowship with the following opportunities:

- 1) Accompanying philanthropy team members on regional travel across Colorado,
- 2) Increasing knowledge of youth mental health and/or reproductive health, and or
- 3) Learning about grantmaking processes and structures.

**The PIFP Summer Fellow will support the following projects and tasks:**

Research and document regional data to inform the philanthropy team:

- Conduct independent research on regional disparities and assets related to youth health and well-being and create data reports
- Complete templates to map regional systems
- Contribute to overall regional profiles for CFC's 11 regions

Support the development and documentation of youth insight and review processes that inform CFC's grantmaking, including organizing and coding qualitative youth input, summarizing key insights for FY27 funding priorities, and assisting with recommendations to strengthen youth-informed decision-making and future review processes.
