Work started in 2022 with the focus of clarifying the policy and has included changing language, researching other college policies, and getting campus input and feedback on the draft. The draft will now enter a 30-day review period that campus is invited to comment on. In addition to the policy, an FAQ will be provided regarding the policy that addresses questions and concerns that may not be appropriate to be included in the policy itself. The goal is to finalize the policy by the end of fall 2025.
