- This year the Membership committee, with input from other board members, updated the WES brochure with current photos and events. The new brochure also reflects the current fiscal year of July 1 to June 30, and the current membership pricing.
- Membership committee members staffed tables at CC Homecoming this
 year, as well as at International Women's Day, of which WES is a sponsor.
 Both were great opportunities to make WES better known in the
 community and attract new members.
- The committee attended the Leadership Pikes Peak 'Get on Board' event in May, recruiting two new board members.

- Graduating seniors from 2021 were gifted a free 3-year membership in WES, and will be offered a discounted membership for the following two years, as a way to keep them connected to WES as they establish their careers.
- Emails to former scholars have been sent to create stronger connections with them, in the hope of recruiting more former scholars to WES membership.
- WES has maintained a monthly online newsletter, the WES Inside Look, which keeps members and contacts up to date on scholar activities, board members and processes, and upcoming events. As a replacement for the snail-mail News Focus, it has offered the chance for more frequent contact with members and supporters, while conserving operating funds.
- Tax receipts are also sent by email, and are sent as renewals and donations arrive, rather than at the end of the year. Using email for these receipts is another way to conserve operating funds.
- We are currently updating the WES website to add current content and create a more engaging platform.

Finance Committee

The Finance Committee evaluates the operating budget, monitors the endowment and determines funding available for scholarships. Since the 1990s, John W. Bristol and Company has managed the WES endowment. As of December 31, 2022, it was valued at \$6,055,301, down over 16% from December 31, 2021.

The Board of Managers' goal is to provide scholars no less than 10% (in 2022-2023 the Board awarded scholarships at 12.5%) of the total cost of attending Colorado College. For academic year 2023-2024, the scholarship will be \$10,400. This amount is again at 12.5% of Colorado College's cost of attendance. The total annual scholarship commitment for 20 students will be \$208,000. The number of scholars in total is 1 less than the previous year but the Board is awarding scholarships 6 new incoming students. WES had two juniors graduate early, resulting in one less in total.

In December 2022, WES received another large donation that was unrestricted and has been set aside in an interest-bearing account. The The Board is still working on

establishing a program to honor Sarah Healy. The funds continue to grow as interest rates have risen substantially since last year.

Markets in 2022 were very challenging with the Federal Reserve trying to get rising inflation under control by raising interest rate from 4.25% in 2022. Ongoing rate hikes in 2023 is driving volatility. The Finance Committee along with its liaison to Colorado College continue to monitor the financial impact on the market, the WES endowment and overall giving to WES.
